on the 9th of June 1859, Federaliah V.  
and State of Indiana personally appeared  
of the peace and filed with me his affidavit  
follow State of Indiana County of  
Federaliah Brown swears that he has  
and that he does fear that W<sup>m</sup> Mc  
kill or destroy his property also fear  
privately injure his person or family  
affidavit solely to secure the protection  
not from any anger or malice

whereupon a warrant was issued directed  
of Adams County and made return  
and delivered to Noah Baxter

on the 9th of June 1859 the Constable  
above warrant by bringing the prisoner  
Court being called the affidavit read and

Count to charge the Jury that even  
if the complaining witness Brown  
did in good faith fear the defendant  
and Campbell would injure him  
property yet if the Jury find  
that such fear arose from the fact  
that Brown's horses died the Jury  
must believe from the evidence  
that defendant killed said horses  
before they can convict the defendant

The State of Indiana County of Adams &  
to my Constable of Adams County whereas Zedekiah  
Brown has filed with me his Affidavit that he has  
Just Cause to feare and does feare that William  
McCampbell will kill or destroy his property also  
feares that he will privately injure his person or  
family and that he makes said Affidavit onely  
to secure the protection of the law and not from  
malice or anger you are therefore Com<sup>manded</sup> <sup>forthwith</sup> to arrest  
said Wm McCampbell and Bring him before me  
at my office to be delt with according to law and have then  
and there this writ dated this 9<sup>th</sup> day of June  
1859
