Said Executor, in compliance with said Order sold at public sale said personal property for the sum of Ten Thousand Nine Hundred Thirty-Seven and 50/100ths Dollars (\$10,937.50) less expenses of Two Thousand Forty-Five and 67/100ths Dollars (\$2,045.67), leaving net proceeds from said sale of Eight Thousand Eight Hundred Ninety-One and 83/100ths Dollars (\$8,891.83), that being more than the appraised value of said personal property.

3. That the Executor believes the sale herein reported be in the best interest of the State and that the same should be approved.

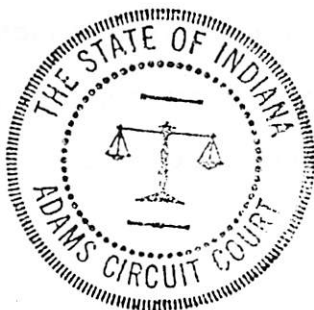
