FINAL DECREE ALLOWING FINAL ACCOUNT  
DESIGNATING DISTRIBUTEES AND DIRECTING DISTRIBUTION

This cause came on to be heard this 7th day of May, 1982, upon the final account petition to settle and allow account and for authority to distribute estate filed by Rose Marie Liechty, Personal Representative of the estate of Daisy M. Aschleman, deceased, which account and petition are in words and figures following, to-wit: (H. I.). And it appearing that no objections were filed thereto and the Court being fully advised in the premises NOW FINDS:

1. Due notice of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate and the same are now properly before the court for final action thereon, which notice and proofs of mailing and publication are in the following words and figures, to-wit: (H. I.).
2. The matters and things stated in said account and petition are true and that said Personal Representative has accounted for all assets in this estate coming into her hands.
3. More than five months have elapsed since the date of the first published notice to heirs and creditors of said decedent, which notice of appointment and proofs of mailing and publication are in the following words and figures, to-wit: (H. I.). All claims against said estate have been paid and discharged; neither said decedent nor her Personal Representative were employers of labor within the meaning of that term as used in Indiana Employment Security Act; all inheritance tax due has been paid, and all adjusted gross
