And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That William C. Aumann, died testate, a resident of Adams County, Indiana, on the 18th day of January, 1978, and his Last Will and Testament was duly admitted to probate before this Court on the 7th day of February, 1978, and this Court appointed said Lester W. Aumann, as Executor of the Last Will and Testament of the decedent, and said Executor was issued Letters of Testamentary on the 7th day of February, 1978, to him and since that date he has continued to serve in such capacity.

1. Said Final Report and Account of said Executor is hereby in all things approved, settled and confirmed.





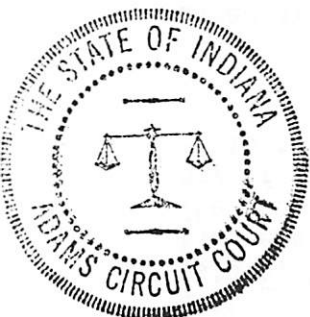
