No. 33 Will of George H. Baker

I George H. Baker of the County of Adams in the State of Indiana do hereby make and publish this my last will and testament hereby revoking and canceling all former wills and testaments by me herebefore made. First I direct that my body be decently entred, and that my funeral be conducted in a manner corresponding with my Estate and circumstances, and as to my worldly Estate which it has pleased God to give me, I Dispose of in the following manner to wit. I give and bequeath unto my son Cornelius Baker all of my notes of hand and book accounts up to this date, on condition of his paying all of my just debts which I owe at this time, Second I direct that my funeral expenses be paid by my Executor as soon as my decease as money can be had from the sale of my personal Estate. Third I give and bequeath to my son Cornelius Baker my three year old mare colt named Sal mare and one set of gears known as belonging to said Sal mare, my large barshair plough, large Harrow, Shovel plough, Stove in room. Cooking Stove, half Side of harness leather and one set of britching on condition of his paying to my wife Mary Baker the sum of twenty five dollars in one year after my decease. Fourth I give and bequeath unto my daughter Lor Baker one bed, bedding

and bedstead worth twenty dollars, one tin kettle, one set of plates one set of cups and saucers one large dish and tin bucket and one coffee pot, one Berian wash stand, dolls, one brass bed and one case. Fifth I give and bequeath unto my wife Mary Baker all of the remainder of my personal Estate, including the twenty five dollars to be paid by son Cornelius Baker in this my last will and testament. And I hereby make and ordain my son Cornelius Baker Executor of this my last will and testament. In witness whereof I Geo. H. Baker the testator have hereunto set my hand and seal this ~~twentieth~~ sixteenth day of April in the year of our Lord one thousand eight hundred and fifty one. Signed, Sealed, Published, and declared by the above named Geo. H. Baker as his last will and testament in the presence of us who have hereunto, subscribed our names as witnesses therunto in the presence of the said testator, and in the presence of ea. other.
