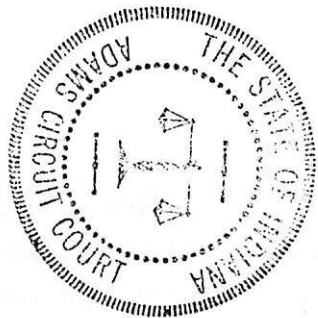
4. Said HOWARD E. BAUMGARTNER, Executor, is hereby directed to file herein his supplemental report of distribution
