This cause came on to be heard this 13th day of August, 1982, upon the final account petition to settle and allow account and for authority to distribute estate filed by JAY H. MARTIN as Executor of the estate of MAMIE P. TEEPLE BROOKHART, deceased, which account and petition are in words and figures following, to-wit: (H. I.). And it appearing that no objections were filed thereto and the Court being fully advised in the premises NOW FINDS:

1. Due notice of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate and the same are now properly before the court for final action thereon, which notice and proofs of mailing and publication are in the following words and figures, to-wit: (H. I.).

2. The matters and things stated in said account and petition are true and that said Executor has accounted for all assets in this estate coming into his hands.

3. More than five months have elapsed since the date of the first published notice to heirs and creditors of said decedent, which notice of appointment and proofs of mailing and publication are in the following words and figures, to-wit: (H. 1. Said report and account of said Executor are hereby in all things approved, settled and confirmed.

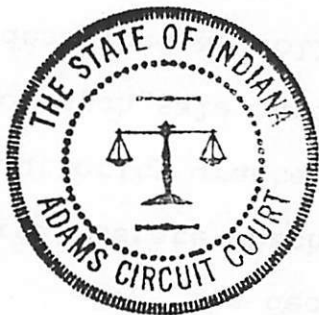
2. Said Executor is hereby directed to distribute and pay over the balance of the estate in his hands for distribution as follows:


