1. That the decedent herein, Blanche Brown, died intestate on the 7th day of March, 1982.

2. That thereafter, on the 12th day of March, 1982, this Court appointed this affiant, Severin H. Schurger, as Administrator of the estate of Blanche Brown, deceased, and the said Severin H. Schurger is the duly appointed, qualified, and acting Administrator of said estate.




