

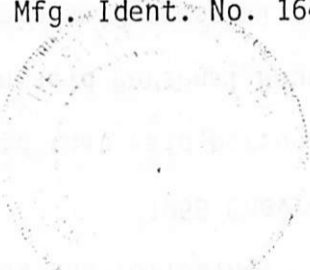
ORDER CONFIRMING SALE AND
