



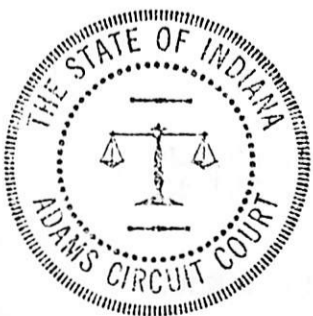
ORDER APPROVING PETITION TO SELL PERSONAL PROPERTY

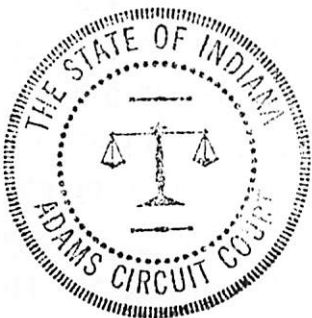
