Comes now the parties and the account of Joseph H Nutterman Administrator de bonis non of the Estate of Isaac N Fordyce late of Adams County deceased, having been settled and allowed by the judgment and determination of this Court at the present term of this Court, by which it was found that there is in the hands of the Clerk the Sum of Eighty Dollars and Eighty one Cents for distribution amongst the Creditors of said deceased, which the Clerk is ordered to pay out to said Creditors in a pro rata payment after deducting the Sum Eight dollars and Eight Cents cost and allowances by the Court, to Commissioners and attorney fees, leaving a balance for distribution the Sum of Seventy two dollars and Seventy three Cents, which is to be paid by the Clerk to the following persons at twenty one and half per cent on the dollars which is as follows to wit:
