1. Said report and account of said Personal Representative are hereby in all things approved, settled and confirmed.

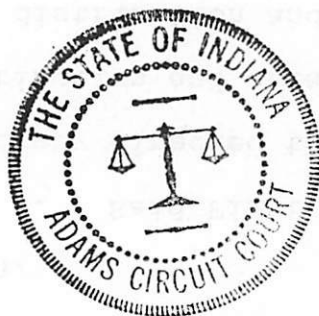
