

1. Said report and accounting of said Co-Administrators is hereby in all things approved, settled, and confirmed.

2. Said Co-Administrators are hereby directed to distribute and pay over the balance of the estate in their hands for distribution as follows:

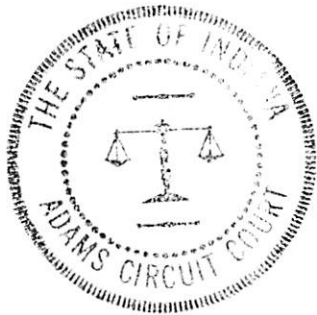




