1. That said Final Report be and is in all things approved.

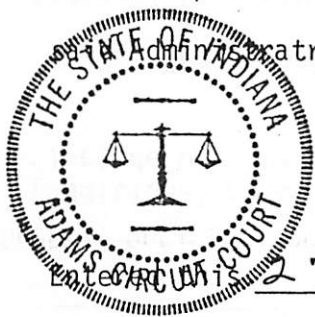

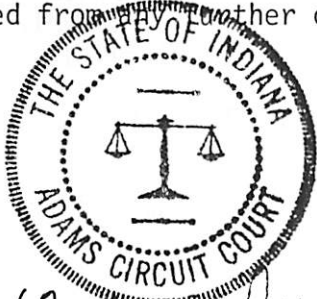
