This cause came on to be heard this  $27^{th}$  day of April, 1982, upon the "Administratrix's Final Account and Petition (1) To Settle and Allow Account and (2) For authority to Distribute Estate," filed by Ilo Jean Schueler, as Administratrix and Personal Representative of Marcus Schueler, deceased, which account and petition is hereinafter referred to as the "Final Account" and reads as follows: (H.I.).

- More than five months have elapsed since the date of (2)the first published notice to creditors and other persons in the estate.
- Due notice of the filing of such Final Account and of (3) the hearing thereon was given to all persons interested in this estate, as required by law.
- No objections to such Final Account have been filed.
- Such Final Account is now ready for submission to the (5)court and for consideration thereof and action thereon by the court.

### Findings of Facts

Having examined and considered such Final Account and being duly advised, the court now finds that:

The amounts claimed as credits for attorney fees are (1)just and reasonable for services rendered to date and normal anticipated services to be rendered in connection with the final distribution of the estate.

- (2) The Administratrix has accounted for all assets in the estate coming into her hands during the administration of the estate and for which she is chargeable by law, except for making final distribution to decedent's heirs.
