- 1. That Sandra Jane Striker qualified as Executrix of the Decedent's Estate on the 2nd day of June, 1980, and said Estate has been fully administered except for potential liquidation of a tract of real estate for payment of federal estate taxes, final distribution and closing of said Estate.
