DONALD GENE BLANKENBAKER GUARDIANSHIP AND FINAL REPORT

Comes now Mildred Vandertook, and respectfully represents that she is the Guardian of the estate of Donald Gene Blankenbaker, a recent minor.

That the Guardianship is no longer necessary and should be terminated for the reason that on November 2, 1960, this ward became twenty-one (21) years of age.

The undersigned Guardian calls the attention of the Court to a clerical error made in the report rendered on June 12, 1959, for the period ending May 9, 1959, in which two of the United States Series "E" bonds were erroneously shown at the purchase value of one hundred dollars (\$100.00) each rather than seventy five dollars (\$75.00) each; these two bonds were the ones shown as Number 43 and Number 44 purchased in August and November of 1957 on the exhibit sheet of United Stated "E" Bonds and accumulated interest in said report. Therefore, the report as approved by the Veterans Administration and the Court and as submitted by the Guardian showed the amount of two thousand three hundred sixty eight dollars and seventy five cents (\$2368.75) purchase price of bonds rather than the amount of two thousand three hundred eighteen dollars and seventy five cents (\$2318.75), which is the corrected amount that should have been shown. Thus, the value of the estate including the purchase price of the bonds and accumulated interest corrected should be two thousand six hundred thirty seven dollars and seventeen cents (\$2637.17) rather than the erroneous amount shown and approved at said time as two thousand six hundred eighty seven dollars and seventeen cents (\$2687.17).
