Comes now Hubert Fuelling, your Petitioner herein, who being duly sworn upon his oath, respectfully petitions the Court as follows:

- 1. That the Petitioner is an adult person and resides at 144

- 3. That the prospective ward is a female, ninety-seven (97) years of age, and is unable to maintain and care for her financial affairs and person and that said prospective ward is presently residing at the Decatur Community Care Center, 1145 Mercer Avenue, Decatur, Indiana, and is unable to consent to Hubert Fuelling being appointed Guardian of her person and estate, whereby said Petitioner states that notice will be given the prospective ward with regard to this proceedings by personal service by the Sheriff of Adams County, Indiana.
- 4. That Bertha C. Boerger is unable to maintain and care for her financial affairs and person due to the fact that she suffers the following incapacities: age and advanced senility, as evidenced by the statement of Dr. H. F. Zwick, which is attached to this Petition and marked Exhibit "A", and made a part of this Petition herein.
 - 5. That the prospective ward owns no personal property.
- 6. That the prospective ward owns an undivided one-half (1/2) interest in real estate located at R. R. #1, Monroeville, Adams County, Indiana, valued at approximately Fifty Thousand Dollars (\$50,000.00).
- 7. That there is no guardian of the person or estate appointed for the prospective ward in this state or any other state.

- 8. That the persons most closely related by blood or marriage to the prospective ward are: (See schedule attached)

Boerger in court is hereby dispensed with and waived pursuant to the statutes of the state of Indiana. And comes now the petitioner herein and now submits and presents evidence on the appointment of said guardian and the court having seen and inspected said petition and being duly advised in the premises, having heard evidence submitted thereon, now finds that the material allegations of the petition are true, and that the said Bertha C. Boerger is a person incompetent to handle her own affairs because of her advanced age and therefore there is a necessity to appoint a guardian. The Court further finds that at the present time the said Bertha C. Boerger is a person owning an undivided 1/2 interest in an 80 acre farm located in Allen County, Indiana but does not own any personal property but instead is indebted to relatives for her care and maintenance.
