



Said Guardian also files herewith his Certificate as to securities and deposits held by him as Guardian of said Ward and tenders the same to the Court to examine.

Said Guardian further shows that he is an uncle to said Ward and that he was duly appointed Guardian on September 2, 1955 and that he is under a Bond in the amount of \$3000.00 with William Bleeke, Decatur, Indiana, and Morris Bleeke, Decatur, Indiana as sureties thereon.

Said Guardian shows that his Ward is now 21 years of age and is residing with his wife in said County.

Said Guardian shows that his Ward arrived at the age of 21 years on the 27th day of September, 1956 and on that date this Guardian has had with



said Ward, a full and final settlement and accounting as evidenced by the receipt filed herewith, for \$3602.41 cash, and securities in the amount of \$5058.77 being in full of all the assets of said Trust with which as such Guardian, he is chargeable.

Said Guardian further shows that he has made a partial distribution in the amount of \$2036.68 from the Certificate of Deposit and the Aid Association For Lutherans of Appleton, Wisconsin as shown by the receipt of said Ward filed herewith.

WHEREFORE, your petitioner prays:

That the Guardianship of the person and estate of said Lehnford Bohnke be terminated.

That your petitioner be discharged of his duties as Guardian to Lehnford Bohnke and that the sureties on his Bond be discharged.
