1. That this undersigned affiant was heretofore by an order  
of this Court, made and entered on the 5th day of July, 1950,

appointed guardian of her daughter Marilyn M. Braun, at that time  
being a minor, 13 years of age. That said guardianship existed  
solely because of the minority of the said Marilyn M. Braun.

2. That this undersigned guardian would further show to  
the Court that her said ward, now 18 years of age, married one,  
Floyd E. Clifton, a person of full age. That said marriage  
took place heretofore on the 19th day of June, 1955 in the  
City of Decatur, Adams County, Indiana.

3. That pursuant to Burns Indiana Annotated Statutes,  
Section 8-147 "A. "A guardianship is terminated", (2) "If the  
guardianship of the person was solely because of the wards  
minority, by the marriage of the ward." (Acts of the Indiana  
General Assembly, 1953, Chapter 112, Section 1947, page 295.)

ORDER TERMINATING

GUARDIANSHIP

This cause being before the Court on the petition of Ella M. Braun (Coffelt) Guardian of a minor Marilyn M. Braun, for an order terminating the guardianship and for approval of her final account.

And the Court being duly advised now finds that the facts set forth in the petition are true and that the guardianship of Marilyn M. Braun, a minor, should be terminated for the reasons that on the 19th day of June, 1955, said minor was intermarried with Floyd E. Clifton, a person of lawful age and other wise competent.

And that the petitioner as Guardian of the estate of Marilyn M. Braun (Clifton), having filed her final account herein and the Court having examined the same, and that it would be in the best interests of said ward if this guardianship were terminated, and there being no objections filed thereto, the Court now finds the same to be true and correct and should be approved and the Guardianship released and discharged of her trust.

WHEREFORE IT IS ORDERED:

1. That this guardianship be and it is hereby terminated,
2. The final account of the Guardian filed herein be and it is hereby approved and accepted,
3. The Guardian be and she hereby is directed to make settlement with Marilyn M. (Braun) Clifton, for all assets remaining in her hands and to make due report thereof to this Court.

And Comes now the Guardian herein, Ella M. (Braun) Coffelt, under order authorizing distribution and terminating guardianship, and reports that distribution of all assets of the guardianship remaining in her hands together with receipts and vouchers therefore.

And the Court having duly examined the same finds that distribution of all the assets of the estate has been made as



provided for in the order of this Court terminating the guardianship herein.

WHEREFORE IT IS NOW ORDERED that the said Ella M. (Braun) Coffelt be and she hereby is released and discharged from the duties of her office as such Guardianship and all liability of the said Guardian and of the sureties on her bond, and the said Guardianship is now terminated.
