The undersigned, John Geels, Sr., Guardian of said Marcile Bertha Geels, Alice Gertrude Geels and John Carl Geels, respectfully submits the following, his report in final settlement of said trust as to his wards.

Said Guardian informs the Court that his ward, Marcile Bertha Geels arrived at the age of 21 years on the 4th day of August, 1952; that his ward, Alice Gertrude Geels arrived at the age of 21 years on the 13th day of July, 1954; and that his ward, John Carl Geels arrived at the age of 21 years on the 14th day of January, 1957.

Said Guardian did further inform the Court that his daughter, Marcile Bertha Geels is now the wife of Paul Alles and that they reside in Fort Wayne, Allen County, Indiana; that his daughter, Alice Gertrude Geels is now the wife of Richard Kline and they now reside in Decatur, Adams County, Indiana; that his son and ward, John Carl Geels, is unmarried and resides at the home of his Guardian, at Decatur, R. R. 2.

Said Guardian informs the Court that during the intervening years there has been no interest paid on said balance due the wards as of August 8, 1949, the sum of \$634.30; that there had been no charge made by the Guardian for expenses, board, clothing and education of his wards, from out of the assets of said Guardianship; and that the Guardian has made no charges as such Guardian, as a fee during the minority of his wards and prior to the time that the Guardianship is to be closed.



Said Guardian further reports to the Court that he has had with his wards, a full and final settlement and accounting and as evidence by vouchers filed herewith, he has paid to each of said wards the sum of \$197.42 in cash, being in full of all the assets of said trust with which, as such Guardian, he is chargeable for said wards.

That in said Final Settlement and accounting, as herein filed, Paul Alles, husband and of Marcile Bertha Geels Alles, has likewise signed such accounting; that Richard Kline has likewise signed the Final Settlement and Accounting with Alice Gertrude Geels Kline.

And such Guardianship having been terminated he asks that it may be so adjudged and he, as such Guardian, may be released and finally discharged.
