- In answer to Petitioner's retorical paragraph seven, said 7. undersigned Co-Guardian states that such statement is merely heresay, as he has consoled with John Briggs of the Geneva Bank at Monroe, who advised him that Glenda Inniger wanted no part of this situation.

appointed representative payee with full knowledge and consent of Paul Gorb by reason of the fact that Mr. Gorb has been removed as representative payee by the Social Security Administration. 
