GUARDIAN'S CURRENT REPORT

In the Mater of the Guardianship of: OPAL GRABER, An Incompetent, SEVERIN H. SCHURGER, Guardian

This undersigned Affiant would respectfully show to the Court as follows, to-wit:

- 1. That heretofore on the 17th day of February, 1969, he was appointed as legal guardian of Opal Graber, an Incompetent and a resident of the Adams County Home, having been transferred there from the Richmond State Hospital.
- 2. That the purpose of said Guardianship was to receive monthly checks from the Adams County Department of Public Welfare, having made application therefore, and upon receiving the same to endorse said said monthly allowances and forward the same to the Adams County Home.
- 3. That beginning with May 1, 1975, federal regulations changed the amount and the method by which a recipient would receive an allowance, and as the result thereof, the Social Security checks were paid directly to the Adams County Home, and in lieu thereof, for her personal use, the sum of \$25.00 per month was allowed per said regulations, payable from the Auditor of the State of Indiana.
- 4. That thereafter, it became necessary for said Guardian to deposit said sums monthly in her checking account, keeping careful records thereof, and paying out necessities to said Opal Graber, his Ward.
- 5. That thereafter, on or about July 1, 1976, further changes were arranged, whereby in lieu of paying \$25.00 per month to the County Home, he was authorized to pay such amounts as would be necessary for the simple needs of his said Ward. That periodic checks were made with the County Home, and as the needs of the Ward arose, he did make such payments.
- 6. That it had become necessary for this undersigned to make periodic reports to the Adams County Department of Public Welfare concerning adjustments to the amount received by said recipient and also to make periodic visits to the Adams County Home to check on the physical life of his said Ward.

- 7. This undersigned Guardian attaches hereto and makes a part hereof, as Exhibit "A", the amounts received by him during said period from April 10, 1980 to April 10, 1982.
- 8. This undersigned Guardian attaches hereto and makes a part hereof, the credits and expenses paid by him from said April 10, 1980 to April 10, 1982, which is marked Exhibit "B".
- 9. This undersigned Guardian attaches hereto and makes a part hereof, as Exhibit "C" is a recapitulation, showing the balance in the hands of the Guardian as of April 10, 1982 of \$798.34.

WHEREFORE, the undersigned Guardian prays that his expenses be allowed therein, and that his services herein, as therein set forth, be approved and allowed, and for all other relief right and proper in the premises, and that this Guardianship be continued.
