9th day of December A.D. 1862. which has come to the hands
or knowledge of Emory Kelly their Guardian, A Cultivated
farm in Jefferson Township Adams County Indiana
containing about 40 Acres about 20 acres of which
is cleared the Rest of which is worth about twenty five
Dollars per annum \$35.00. And 40 Acres of land in
the woods in the said Township. The whole of said
land is worth about Eight hundred dollars \$800.00
There has no personal property of any description

January Term 1863, the 3rd day, January 14th 1863
 came to my hands but there is some personal property
 in the hands of the Administration of the Estate of
 Washington Kelly the father of said Minors But
 what amount will be left after said Estate is
 finally settled cannot now be told by me or
 whether there will be any left for the said Minors
 is unknown. I would further suggest to said
 Court that since my appointment as Guardian
 of said Minors, one of them to wit: Delinda
 has departed this life.
