and says:

1. That heretofore on the 13th day of January, 1971, he was
appointed as guardian of the person and property of Anne Laura
Massonne, an Incompetent adult, by this Court.

2. That he submits herewith his current report in said
Guardianship from the date of April 10, 1980 to April 10, 1982.


3. That he attaches hereto and makes a part hereof as Exhibit
"A" a list and schedule of all of the income received by him during
the course of this Guardianship.

4. That he submits herewith and attaches hereto and makes a
part hereof as Exhibit "B", a list of all of the expenses and credits
to him as such Guardian during the course of said Guardianship.

5. That he submits herewith and makes a part hereof, as
Exhibit "C", a recapitulation of the assets received, and monies
expended during the course of said Guardianship, showing a balance
thereof, totally in the hands of said Guardian of \$1,537.25. Your
undersigned Guardian is informed that his ward is permitted to have a
total of \$1,500.00 to her credit at any one time and that, therefore,
the balance as shown on said Schedule "C" exceeds the amount of said
limit. That upon notice from the Adams County Department of Public
Welfare, he will make re-payment to them of any excesses in the
account.

WHEREFORE, the undersigned prays the Court for an Order
approving his current report herein, and requesting that said
Guardianship be continued.


