
GUARDIAN'S CURRENT REPORT AND ACCOUNTING
AND PETITION TO TERMINATE GUARDIANSHIP,

Sally Wiseman Beahrs, Guardians of the above Ward, being first duly sworn upon oath, respectfully shows to the Court that:


1. That on March 15, 1978 Letters of Guardianship were issued by this Court appointing Sally Wiseman Beahrs guardian of the estate of Douglas L. Wiseman.
2. That Douglas L. Wiseman is now an adult having reached the age of Eighteen (18) years on February 15, 1982.
3. That by petition in this Court Douglas L. Wiseman had his name changed to Douglas L. Beahrs on March 22, 1982.
4. That your Guardian filed her first current report on August 8, 1980, which report was approved by the Court.
5. The the Guardians current accounting for the period April 15, 1980 through April 5, 1982 is attached hereto and marked Exhibit "A".
6. That in view of the fact that Douglas L. Wiseman (Beahrs) is now over the age of Eighteen (18) years your Guardian petitions the Court to enter an Order terminating the Guardianship, permitting the Guardian to make distribution of the Ward's estate to the Ward, accounting to the Court for the same, and to be discharged from all further duties as Guardian.

7. The Guardian's attorney should be allowed a reasonable attorney fee for their services rendered during the period of this accounting, for the preparation of this report, for the preparation of a final accounting in the event your Guardian is discharged and the Guardianship terminated and a reasonable fee therefore is the sum of Sixty Dollars (\$60.00) per hour for said services plus advanced expenses.

WHEREFORE, Sally Wiseman Beahrs, as Guardian, prays that this current report and accounting be approved along with the proposed attorney fees, that the Guardianship be terminated and that the Guardian be permitted to distribute the Ward's estate to the Ward, that the Guardian be discharged of further duties upon the filing of a final report and report of distribution, and for all other proper relief in the premises.

Comes now the Guardian in the above captioned cause and files her Current Report and Accounting and Petition to Terminate, which is in the following words, to-wit

THE COURT having reviewed said Current Report and Accounting and being duly advised in the premises does now approve said Report.

THE COURT having reviewed the Petition to Terminate and being duly advised in the premises does now find that Douglas L. Wiseman (now Beahrs) has now reached the age of Eighteen (18) years, is not otherwise incompetent, and therefore said Guardianship should be terminated and the Ward's estate should be distributed.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, that the Guardian's Petition is granted, the Guardian should pay the Court costs herein accrued, distribute the Ward's estate to said Ward obtaining a receipt for same, file the said receipt with the Court at which time the Court will consider her Petition for Discharge.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that the Guardian may pay a fee to the attorney for the Guardian of Sixty Dollars (\$60.00) per hour for time expended in preparing the Current Report and Petition to Terminate and related services.
