I, Wm Böhne widower, residing in Post Township, Adams County, Indiana, being of sound mind and disposing memory, do make and publish the following as my last will and testament

First To Wm. Böhne my eldest & lone already given son in the estate by deed eighty (80) acres of land situated in Madison township Allen County, Indiana.

Second I bequeath to Henry Böhne the following described land, situated in Post township Adams County, Ind.: The E^{1/2} of S.W. 1/4, Sec. 10 township 25 North Range 14 East consisting of 80 acres of land and all improvements thereon belonging, one cow and one bed.

Third To Louis Hockmeyer, I bequeath one thousand dollars to be paid to her by August Böhne my son as herein further described.

Fourth To Fred Böhne I have already given two shares in the estate by deed eighty (80) acres of land situated in Madison township, Allen County, Indiana consisting of one hundred thirty eight (138) acres more occupied by him situated in Post township, Adams County, Ind. with house and all improvements thereon belonging, in consideration of the above bequest he shall pay to Sophia Luttman one thousand dollars, and to Henrietta Böhne one thousand

Fifth To Sophia Luttman one thousand dollars, and to Henrietta Böhne one thousand dollars to be paid her by Charles Böhne as stated in item five (5)

Sixth To Henrietta Böhne I bequeath one thousand dollars to be paid to her by Charles Böhne as stated in item five (5).

Seventh To August Böhne I bequeath the farms owned by myself, except the eighty (80) acres bequeathed to Henry Böhne, consisting of one hundred and twenty (120) acres situated in Post township, Adams County, Indiana, with house and all improvements thereon, and all my personal property, in consideration of the above bequest he is to pay to Louisa Hockmeyer one thousand (\$1,000⁰⁰) dollars
