LAST WILL AND TESTAMENT OF HENRY A. BORNS

In the name of the Benevolent Father of all I, Henry A. Borns of Decatur, Adams County Indiana being of sound and disposing mind and memory hereby declare this to be my last will and testament revoking all wills formerly made.

ITEM 1. It is my will that as soon after my decease as possible my Executrix hereinafter named pay all of my just debts.

ITEM 2. It is my will and I instruct my Executrix to pay the sum of Two Hundred Dollars (\$200.00) to the pastor of the St. Marys Catholic Church, Decatur, Indiana said sum to be used for masses to be read for the repose of my soul.

ITEM 3. I hereby instruct my Executrix to place a suitable marker upon my grave with the provision that an added space be allowed on the said marker for the insertion of the name of my beloved wife. Not to exceed the sum of Three Hundred (\$300.00) Dollars.

ITEM 4. I hereby devise and bequesth to my beloved wife Helen E. Borns all of my real estate, and all of my personal property, of every kind and description she to have and hold the same in Fee Simple Absolute, and forever.

ITEM 5. I hereby nominate my beloved daughter Virginia Schurger to act as Executrix of this my last will and testament.
