LAST WILL AND TESTAMENT

I, Lill Borroughs, being of sound mind and disposing memory, and realizing the uncertainty of life and the certainty of death, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking any wills or will by me heretofore made.

ITEM 1.

It is my will that after my death, all of my just debts, funeral expenses, costs of last sickness and costs of administration, shall be paid out of the assets of my estate.

ITEM 2.

I give devise and bequeath my home located at 210 Rugg Street, Decatur, Indiana, the same being a part of Inlot No 351 in the Southern Addition to the Town, now City of Decatur, Indiana, to Margaret Melchi and Cecil Melchi, her husband as tenants by the entirety, absolutely and in fee simple.

ITEM 3.

I give and bequeath the following personal property to the following named persons to-wit:

- b. My diamond cluster ring to Mary Jane Speicher
- c. My single diamond ring to Betty Moser
- d. My Amethyst Ring to Tanya K Moser
- e. The residue of my household goods, dishes and cut glass shall be divided by my executrix hereinafter named among my nieces in equal shares.

ITEM 4

The rest and residue of my estate I hereby give, devise and bequeath to the following named persons share and share alike, namely: Judy Hebble, Sharol Ashbaucher, Phyllis Speicher, Eddie Speicher, Tanya K Moser, Sandy K Moser and Kim Goodin.

ITEM 5

I hereby nominate, constitute and appoint my niece Margaret Melchi as executrix of this my Last Will and Testament and request that my executrix shall serve without bond, or if bond is necessary, that the amount of said bond be the minimum allowed as in the discretion of the Court will provide protection for creditors and taxing authorities.
