Last Will and Testament of Christian Scherry

729. In the name of the Benevolent Father of All:

Declarator, Indiana August 1st 1903.

I, Christian Scherry of Adams County, Indiana being of sound mind and memory hereby make and publish this my last will and testament hereby revoking all former wills by me made:

Item 1st:

It is my will that at my death all my just debts and funeral expenses be first paid which shall include a suitable monument at my grave.

Item 2nd

I will and bequeath all my personal property of all description whatever, including money, all beds and household goods now at my son Fred's residence in Preble Township to my three daughters viz: Catharine Schwartz, wife of Fred Schwartz, Louisa Frucht, wife of E. Lewis Frucht, and Carolina Kraft, wife of George Kraft they to take the same share and share alike.

Item 3rd

I nominate and appoint my son-in-law E. Lewis Frucht executor of this my last will.
