# THREE DEATHS RESULT FROM FIRES EXTINGUISHED BY BERNE FIREMEN IN 1950 ANSWER 25 ALARMS

The Berne firemen answered 25 fire alarms during 1950, 10 in Berne and 15 in the rural areas surrounding Berne, according to a report submitted today by E. E. Bixler, fire chief, and Hallman Schindler, secretary of the local fire department. Three deaths, one in Berne, and two outside of the corporation resulted from three of those fires, and while the property loss was not exceptionally high, the loss of life gave the year's fire loss a tragic note.

The property loss in the 10 local fires was estimated at \$2810 by fire chief Bixler. He did not make an estimate on the loss in the rural fires, but it was fairly heavy. The most costly rural fires were the Junior Ray barn in Monroe township, the Ray Thomas home in Hartford township, the William Johnson home in Blue Creek township where their son was painfully, but not seriously burned and the Grover Groves farm in Nottingham township, Wells county.

#### THREE MEET DEATH

The three persons who died as a result of being burned in these fires were Menas Graber, an employ of Graber Produce, who died several hours after being badly burned on Sept. 15 in a fire which followed an explosion at the plant. Mrs. Amy Tembring, 19, of Grand Haven, Michigan, burned to death in a fire which followed a truck mishap north of Berne on Sept. 23, and Harve Eckrote, who was badly burned in a fire at his home adjoining the Franklin Sprunger residence north of Berne and who eventually died from these burns and complications.

Had it not been for the prompt response to all of these alarms by the local fire department and for their valiant efforts in battling the fires when they arrived on the scene, the financial loss would have been much heavier.
