YOUNG WOMAN DIES TODAY AT CO. HOSPITAL Mrs. Chris Inniger, 22, Dies Following Operation Last Night FUNERAL ON SATURDAY P.M.

Mrs. Esther Habegger Inniger, 22, wife of Chris Inniger of Monroe township, died this morning at 9:35 o'clock at the Adams County Memorial hospital at Decatur. While her condition was critical last night, her death came as a great shock to her large circle of relatives and friends. She was formerly employed at the Nussbaum Novelty Co.

According to the attending physician, death was caused by paralysis of the large bowel. Mrs. Inniger had been in ill health for several months and was bedfast much of the time. Recently, however, her condition was was greatly improved and she was able to be up and around until last week when she suffered a relapse. For two days her temperature was over 104 degrees, but Tuesday she was thought to be improved. Yesterday her condition became serious and last night she was rushed to the hospital where an operation was performed as a last effort to save her life. This morning she was conscious for a short time, but her condition was very weak. Mrs. Inniger suffered much during the past several days.

Her husband is employed at the Homer Furniture Company in Berne.

The deceased was born in Monroe township on May 4, 1911, a daughter of Joel H. and Elizabeth Mazelin Habegger. On Sept. 4, 1932, she was married to Chris Inniger and the couple had resided two miles north and a short distance west of Berne.

Surviving are the sorrowing young husband, the mother, the step-father David Schwartz and the following brothers and sisters: Noah L. of Berne; David, Barbara, Reuben and Agnes, all at home, Mrs. J. D. R. (Edna) Schwartz of Monroe township and Mrs. Menas (Lena) Graber of Berne.

Her father preceded her in death July 13, 1931, and a sister Verena, after many years of illness died on Jan. 21, 1932. Two brothers preceded in infancy.

The deceased was a member of the A. C. church.

The body was brought to the Bierie and Yager Undertaking establishment here and will be removed to the Inniger home from where funeral services will be held Sat. afternoon at 2 o'clock. Burial will be in the A. C. church cemetery two miles north and one-half mile west of Berne.
