INJURIES IN FALL FATAL TO ARCHIE LONG, 61 Local Man Dies In Veterans Hospital in Ft. Wayne; Rites Saturday

Archie Long, 61, well-known local man and a resident of Berne for many years, died at 10:30 p.m. Wednesday at the Veteran's Hospital in Fort Wayne where he had been a patient since Dec. 23. Mr. Long died from complications resulting from a fall on the ice on Dec. 22.

The local man was on his way home after being uptown when he slipped on the ice and fell. The mishap occurred near the Trinity EUB church. He suffered a broken pelvic bone. He was admitted to the Adams County Memorial hospital and transferred to the Veteran's Hospital the following day. He became seriously ill soon afterwards, had high temperature and slipped into a coma.

An autopsy was held on the body Thursday at Fort Wayne. Death was attributed to bronchial pneumonia.

Mr. Long was a lineman with the Citizen's Telephone Company for many years, retiring from this work in 1931. He was employed by the General Electric Company during the war. He had not been well for several years.

Mr. Long was a veteran of the World War I. He was a member of Berne Legion Post 468 and formerly a member of Adams Post at Decatur.

The deceased was born in Adams county July 22, 1890. He was married to Lulu Burgens of Marion on May 7, 1921. She survives, also a step-daughter, Mrs. Mary McCollum of Camp Roberts, California, and one step-grandchild.

The body is at the Yager Funeral Home where friends may call until time of the funeral which is 2:30 p.m. Saturday. Rites will be held at the local EUB church which he attended. The Rev. Karl Tauber will officiate. The casket will not be opened in the church. Burial will be in the M.R.E. cemetery.
