### LOCAL MAN HAS LEG AMPUTATED

A. Clayton Smith Undergoes Operation at Hospital Wednesday

A. Clayton Smith, well-known local man, Wednesday submitted to an operation for the amputation of his right leg. Local doctors performed the operation, which took place at the Adams County Memorial Hospital. The limb was amputated under the knee and flesh grafted so that an artificial leg may be more easily fitted.

The condition of Mr. Smith was reported to be satisfactory today.

Mr. Smith has had considerable trouble with the leg which was shattered in an automobile-train accident on Nov. 14, 1932. He has suffered several attacks of blood poisoning and physicians agreed that the amputation of the limb was the only course left.
