Mrs. Sprunger was born on August 8, 1900, bringing her age to 33 years, 6 months and 6 days. She was married to Mr. Sprunger May 8, 1924.

Surviving are the husband and two children, violet 8, and Donald S. the parents, Mr. and Mrs. Chris Roth both survive also the following brothers and sisters: Frances and Glen at home, Mrs. Emma Mankey, John, David and Albert all of near Decatur and Fred of Fort Wayne. SLAYING OF WABASH MINISTER IS OF SPECIAL INEREST IN BERNE

Not only was the slaying of Rev. Gaylord V. Saunders, former Wabash pastor, one of the strangest cases of murder in the history of Indiana, but the crime is of special interest here. Rev. Saunders, until a few months ago, was pastor of the M.E. Church at Wabash, and officiated in the wedding of Everett Sheets of Decatur and Mrs. Florence Schindler of this place in what is said to have been the last wedding he performed. That was in August. He quit the ministry to take a course in undertaking and embalming at Indianapolis.

Indiana has been rocked time and again by murders, but his one, for sheer cold bloodedness, is said to surpass most recent crimes of this kind. His widow, according to her own confession, hired Joseph T. Mathers, aged 19 of Indianapolis to kill Saunders for ten dollars. Mrs. Sunders claims that her husband acted queerly, had made an attempt in January to commit suicide and that she was afraid to live with him any longer.

The three persons held for the crime are the slain pastor's wife, Naomi Saunders, aged 36, Theodore Mathers, aged 19, roommate of Saunders, and Masil Roe, aged 19 former classmate of Mathers.

Only Survivor of Ft. Wayne Suicide Pact Family Improved 1934

Fort Wayne, Feb 15 – The last of the Larwills, Miss Louise, aged 27, only survivor of the death pact her family signed Tuesday, was resting easy at the Lutheran Hospital today and was apparently recovering from the effects of gas she breathed in an effort to end her life with her sister and parents.

Hospital attaches said the young woman spent a fairly restful night and that her condition was good. Funeral arrangements for the other members of the Larwill family, Kenneth, the father; Mrs. Mary K., the mother, Miss Mary E., a daughter, whose death from natural causes late Monday night precipitated the family agreement to commit suicide, have not been completed.

The husband of Mrs. Smith has a large number of relatives here. He is a close relative to the John P. Nussbaum family, and also has many relatives among the Mazelins in this community. Mrs. Smith and her husband, now almost totally blind, have visited here many times.

It is expected that he pictures and lecture by Mrs. Smith will be very interesting. Many here remember when Art, her son, started building his first airplane and how after many months and years of struggling he became one of the world's best known aviators. The family was poor and the parents mortgaged their home to provide money for Art's airplane, and later Mr. Smith's eyesight failed, but the parents had faith in their son and finally he was able to pay them back many times over for the money they paid for him. It is expected that Mrs. Smith will relate some of those stirring and trying moments of years ago, when the public thought Art was a fool for experimenting with aviation. Mr. and Mrs. Smith last March celebrated their 50^{th} wedding anniversary. Because of ill health he will be unable to accompany his wife to Berne.
