Relatives who attended the funeral of Vilas Zuercher of Rittman, O., last week, have described how the accident happened which cost the lad his life. He poured kerosene into the stove and the flames shot into the kerosene can, blowing out the bottom of the can and throwing blazing fluid over him. He rushed out and got as far as the garden when he fell down. Members of the family extinguished the blaze with blankets. Flames shot two feet above his head at times. He was rushed (cut off)

Barn Burns at Home Near Rochester; Implements Burned

According to information received here by relatives, Edgar Habegger, of near Rochester, Ind., formerly of this community, suffered a heavy fire loss last Friday night. A barn containing

nearly all of his farming implements was destroyed. Mr. Habegger is a son of Mrs. Ben Habegger of Berne.

The origin of the fire is not known. Practically all of the implements except those he uses during corn planting time were in the barn and were destroyed. There was no insurance on the implements.

If you have any extra cushions we are sure Adolph will appreciate it very much if you turn them over to him.

"Lucy Fiddler" as he is generally known was helping his brother repair a tile drain Saturday. He became tired and decided to sit down for a minute. He noticed one spot where the grass seemed to be nice and soft and there he sat down. Mr. Liechty was accorded a warm reception, however, as he sat down right in the midst of a bumble-bee nest.

He received numerous stings in rather tender spots and while no official word is available on just what kind of words he used, it reminded us very much of the last line of a poem recited once by a Chinese who was stung by a bumble-bee - "Melican bumble bee velly much hot".
