GOVERNOR TO SPEAK AT CENTENNIAL

State Official To Dedicate Tablet to Pioneers Friday; Legion Day Planned; Fraternal Events Held.

Decatur, Ind., Gov. Paul V. McNutt and four Civil War veterans will be the honored guests on the dedicatory program Friday at 3:30 pm (C.S.T.) sponsored by the Decatur Centennial Association and the Adams Post No. 43 of the American legion.

The memorial tablet already has been erected on the northeast corner of the Court House square. It will be dedicated by Governor McNutt to the pioneers and early settlers of Adams County. It was purchased and dedicated by the Centennial Association.

Arrangements for the unveiling program have been made by a committee headed by Lloyd Baker, representing the American Legion.

The four Civil War veterans, who will be honored on the speaking platform on the Court House steps are: Silas Hale, of Geneva; David Baker, of Pleasant Mills; Howard Parr, of near Berne, and R.A. Drummond of Decatur.

The tentative program is:

Firing of the Governor's salute; band selection, "Indiana"; presentation of Judges James T. Merryman, first Mayor of Decatur, by Carl Pumphrey, president of the Centennial Association; Governor's address.

Unveiling of the tablet by Phillip B. Thomas and Ruth Holthouse; community singing, "Star Spangled Banner."

Vets to Parade

Friday also will be American legion Day. In the night parade more than a score of drum corps will compete for prizes as large as ever given at a state convention. Among the state Legion officials expected are: Dr. A.R. Kilian, state commander; Edith Lemstra, president of the State Legion Auxiliary; William Sayere, state adjutant.

Friday morning one of the outstanding attractions of the Centennial, will be held, the lightweight horse pulling contest at 9 am (CST). This will be held on the field adjacent to the Legion Memorial Park.

This evening at 6:30 o'clock a banquet will be held at the Decatur Country Club for former residents and present citizens of Decatur. J. B. Malone, attorney of Springfield, O., and New York City, will be the principal speaker.

Fireworks Postponed

The fireworks display which was to be held Wednesday at 10 pm at Niblick Field as the concluding event of the fourth day of the Centennial was postponed because of rain. The display will be held tonight if weather permits. It was feared early Wednesday evening that the gala parade, high light of the day's program, would have to be postponed due to threatening rains throughout the evening.

Today was Fraternal Day, lodges holding open house for out-of-town members. The Jersey Parrish, the Adams County Holstein and the balance of the Adams County 4-H Calf Club show was held this morning. Horses were also judged.

The aged bull entered by Mark Miller, of Huntington County, took the ribbons for the champion senior bull and the grand champion bull at the Guernsey show held Wednesday. The junior champion bull is owned by Kelsey, Lesh and Son, also of Huntington County.

Cut flowers, historical objects, hobbies, industrial exhibits and a number of other articles were judged today and hundreds of ribbons distributed.

Wilma Miller was adjudged the winner in the demonstration contest of the girls' 4-H Home Economics projects held Wednesday. She is a resident of Washington Township and will represent the county in the district contest next November.
