### PRETTY CHURCH WEDDING HERE SUNDAY PM

Miss Arvada Habegger and Percy Gould Married Here

### BROTHER OF BRIDE OFFICIATES

Miss Arvada Habegger of this place became the bride of Percy Gould of near Monroe, in an impressive and lovely ceremony performed at 4 o'clock Sunday afternoon at the First Missionary church. Quite a number of relatives and friends witnessed the wedding. Rev. Tillman Habegger, of Detroit, brother of the bride, officiated at the single ring ceremony.

Miss Daisy Augsburger and Raymond Cox attended the couple. Wilford Habegger and Rufus Kneuss served as ushers.

The church was beautifully decorated for the occasion. The aisle corsages were made of pink and white crepe paper, roses and ferns, which led to an alter of ferns, mock orange blossoms, peonies and roses, before which stood a candelabra with lighted candles.

Preceding the ceremony, a musical program was given by Gladys Schindler Chrisman, pianist, and Clyde Sprunger, vocalist. "Liebestraum" by Liszt, was the first piano selection by Mrs. Chrisman and was followed by, "O Perfect Love" sung by Mr. Sprunger. The next piano number was a medley of favorite wedding tunes, and Mr. Sprunger then sang "Because." The final number of the program was music taken from Mendelssohn's "Midsummer Night's Dream," which directly preceded the wedding march. During the ceremony Mrs. Chrisman softly played her own variations of "Liebestraum." Mendelssohn's wedding march was used for both the processional and recessional.

The bride was given away in marriage by her father.

For the ceremony the bride chose a gown of floor length white satin striped organel, with finger tip veil flowing from a white satin rosette turban. She carried a corsage of Talisman roses.

The bridesmaid wore a dress of powder blue satin striped organel, floor length and a blue tulle veiled hat. Her corsage was a bouquet of tea roses.

The groom appeared in a suit of dark blue and the best man wore oxford grey.

The bride, a daughter of Mr. and Mrs. Louis Habegger, has been employed for several years at the Berne Review print shop. She is a graduate of the Berne High School and also from the Ft. Wayne Bible Institute where she took a Bible-Music class.

## MUSELMAN LAD BADLY INJURED

### Arthur Muselman, 6, Seriously Hurt When Hit By Car

Arthur Kenneth Muselman, aged 6, son of Mr. and Mrs. C. H. Muselman of this place, was very seriously injured Thursday evening at 8 o'clock when he was struck and run over by a car driven by Earl Haines east of town. The accident happened in front of the Steiner sisters' home just east of town, along road No. 118.

Arthur suffered two fractured legs above the knees, a very badly fractured and splintered right arm, bad cuts to the abdominal region, severe cuts and bruises on his face and head and also the loss of several teeth.

The lad was taken to the office of a local physician and was then removed to the Adams county Memorial hospital in the Bierie and Yager ambulance.

Arthur and his brother, Carl, and sister Ruth had been visiting at the Rufus Hirschy home during the afternoon and were returning to their home here when the mishap occurred. Mr. Hirschy brought the children as far as the tile mill, and from there they wanted to walk home, and Mr. Hirschy finally told them they could walk if they would be very careful.

Just a few minutes later the Haines car, coming from the east, struck the Muselman boy. Mr. Haines was absolved of all blame.

Mr. Muselman was at Findlay, O., at the time of the accident and was summoned home.

None of the other children in the party were injured, but the car had one head-light broken.

The injured boy is a likable little chap and his many friends hope he will make a complete and swift recovery.

Doctors could not find any internal injuries and they believe if infection can be prevented, his chances for recovery are bright. The boy's right arm was broken in two places and the bones were protruding through the flesh when he was picked up.

## DWIGHT YORDY FAMILY MOVING TO CENTRAL KANSAS

Mr. and Mrs. Dwight Yordy and family of Detroit, Michigan, stopped in this community for several days on their trip to central Kansas where they will make their future home.

Mr. Yordy was formerly of this community and lived in Linn Grove. He is a son of the late Albert Yordy who was at one time manager of the Berne Equity Exchange.

Andrew Yordy, deceased, who was the grandfather to Dwight was one of the earliest settlers in central Kansas, coming from Switzerland.

He was married in this country and took up cattle raising as his occupation. His first few years were years of hardship as it was necessary to cut the top of his covered wagon in which he was making his trip west, for winter clothing.

A family of six boys and three girls grew up on this government homestead. As more profitable years came he accumulated more land, which after his death was divided among the children still living.

Mr. Yordy and his family will make their home with his uncle James Yordy who is nearly 73 years old and will assume complete charge of 320 acres of the Yordy ranch which is located about 60 miles northwest of Newton, Kansas.

Frederick Schlagenhauf of west of Berne will assist Mr. Yordy in driving his truck and family car to their new home which is located on Mulberry Creek, near Brookville, Kans. Mr. Schlagenhauf will assist in the wheat harvest this summer before returning to his home.
