#### Thursday, December 10, 1936

Rev. Paul W. Schultz, pastor of the Zion Lutheran church for the past ten years. An ardent and zealous worker, Rev. Schultz has seen his congregation grow to more than 100 families and 300 communicants and realizes a dream with the dedication of the new beautiful house of worship.

Rev. Schultz was born in 1900 in Niagara Falls, N.Y. He attended parochial and high school in the east, entering college in 1917. He graduated from the Concordia Theological Seminary, Springfield, Illinois, one of the two ministerial schools of the Missouri synod of the Lutheran church, in 1925. Served a Lutheran congregation near Springfield, Illinois, as student pastor while finishing the last year of the seminary work.

Rev. Schultz served as student pastor and teacher in a Lutheran congregation at Lorain, Ohio, for one year, served also as student pastor and itinerant missionary in the northern section of Wisconsin and Michigan for one year, residing while there in the city of Ironwood, Michigan.

He was called to the local Zion Lutheran church in January, 1926, and installed as pastor February 14, 1926, having served the local church for 10 years. Rev. Schultz was married to Miss Frieda Brauer of Cleveland, Ohio, May 22, 1926. The couple has been blessed with four children, two boys and two girls: Edna Mae, Marelyn Ann, Paul Gerald, and David Norbert.

## Thursday, January 14, 1937 SAM STEINER IS SENTENCED AT DECATUR LOCAL MAN GIVEN 10-DAY JAIL TERM, AND FINE OF \$10

Sam Steiner, aged 42, of Berne, appeared before Judge Huber DeVoss this morning and pleaded guilty to a charge returned against him recently through a grand jury indictment. Judge DeVoss sentenced Steiner to ten days in the Adams county jail and fined him \$10. Steiner paid the fine and was then taken to the Adams county jail to serve his sentence. C.H. Muselman of Berne was council for Steiner.

The charge against Steiner grew out of an automobile accident on Nov. 24. Steiner was arrested on a drunken driving charge, following a head-on collision with a car driven by Rollie Richards, of Decatur. The accident occurred north of Berne, on road 27. The grand jury then

investigated the accident and returned an indictment. Steiner was arrested Jan. 4 and when arraigned he asked for more time to plead. He was released under bond.

Other indictments returned by the grand jury were against Rex Sheets, William Huffman, Ralph Isch and Elver Foreman. The first three were sentenced and Foreman pleaded not guilty. He will come up for trial later.

## Monday, October 26, 1936 COLD WEATHER ARRIVES HERE FREEZING TEMPERATURE IS PREDICTED FOR TONIGHT

Cold weather, with freezing temperature, is scheduled for tonight, according to the weather forecast today. The forecast is for cloudy and colder tonight, with fair weather Tuesday and rising temperature in the afternoon. The lowest tonight is expected to be below 30 degrees. Winnipeg, Manitoba, reported 6 degrees below this morning, and weather stations in Minnesota reported as low as 6 above.

The first general frost of the season occurred Friday night, when the temperature tumbled to 32 degrees. A heavy frost occurred, but not all of the green vegetation was killed.

A heavy rain which fell last night preceded the cold weather.

The wet weather is causing delays to the harvest of soybeans, potatoes and sugar beets, and farmers are hoping for several days of fair weather.
