R.L. Hilton, who brought the world's largest fancy box order to Berne for two years, has severed his connections with the Nussbaum Novelty Company here, to start manufacturing his own product.

Mr. Hilton's company will incorporate under the name of Floron-Craft, specializing in "stainless steel" novelties, retailing at \$5.00 and up, mostly up from what we saw. The company is located at Chicago.

Mr. Hilton brought a quarter of a million dollars worth of business to Berne, by securing two large fancy wooden box orders for the Nussbaum factory here, and local people regret to see him leave Berne.

## CHILD EATS PILLS, DIES

CAROL SILL, AGED 2, NEAR MONTPELIER, SUCCUMBS AT HOSPITAL IN BLUFFTON

BLUFFTON, Ind., March 28.-Carol Joan Sills, aged 2, daughter of Mr. and Mrs. Russell E. Sills, living one mile west of Little Chicago, near Montpelier, died in the Wells County Hospital Monday afternoon at 5 o'clock after eating several medical pills at the home earlier in the day.

The pills, obtained by the child's great-grandmother for her rheumatism, contained sodium nitrate and barbatol sodium. The great-grandmother was staying with the child at the time, while the parents were shopping in Bluffton.

#### PARENTS NOTICE ILLNESS

When the parents returned, they noticed the child's illness. She was taken to a Montpelier physician, who advised her removal to a hospital. She died shortly after being admitted.

Coroner William McBride investigated the case. Funeral services and burial probably will be at Montpelier.
