DECATUR TRAIN WRECK KILLS THREE PERSONS

Erie Railroad Train Crashes Into Caboose of Another Freight

Decatur, Feb. 15 - With a roar that could be heard a mile, a westbound Erie freight train telescoped the rear cars of another which had been stopped during a blinding snow storm a mile and a half east of here about 10 o'clock Sunday morning, killing two trainmen instantly and seriously injuring two others, all from Huntington.

The dead:

James H. Karns, 67, conductor, 1208 Bryon Street, Huntington.

Edwin Nevis, 54, extra conductor serving as flagman on the ill-fated train, 503 Mayme Street, Huntington.

Lawrence McConkey, 35, of Huntington, an Erie railroad fireman, who died at 11:45 Sunday night at the Adams County Memorial Hospital. He suffered third degree scalds and other injuries in the train crash.

Charles Patterson, 73, engineer of Huntington is in a serious condition, suffering from scalds, cuts and bruises. Brakeman Victor C. Leatherman, 40, of Huntington, jumped from the moving train and escaped with crushed fingers on the right hand. He was released from the hospital today.

W. M. Sporleder of Huntington, superintendent of the Erie's Marion division, who with Claim Agent Robert Dinnen, also of Huntington, spent most of Sunday investigating the wreck, refused to comment on the pileup. Mr. Sporleder returned to Huntington after a trip to Ohio City, O.,

apparently to check orders issued to those in charge of the second train. Heavy snowfall is believed to have contributed to the (Continued on page 4 - not included)
