John Neuhauser, son of Jacob and Mariam (Biberstein) Neuhauser, was born in French township on Jan. 7, 1861, and departed this life at his home in Berne, Ind., Dec. 5, 1938, at the age of 77 years, 10 months, 29 days. On March 17, 1883, he was united in marriage to Christina Steiner, who preceded him in death on August 18, 1916. To this union were born 2 sons and 4 daughters.

Children surviving are Amos Neuhauser, Mrs. Noah (Amanda) Schlotzhauer, both of Bluffton, Ind., and Mrs. Joel (Sylvia) Moser of Berne, Ind.

Children preceding him in death were Albert, Clara and Elma, the latter in her infancy. He is also survived by 12 grandchildren. One preceded him in death, Eugene Schlotzhauer.

Four great-grandchildren, one brother Jacob, also one sister, Mrs. Jacob Amstutz, both of Berne, Ind.

On April 27, 1930, he was united in marriage to Miss Anna Hanson, who today with the children, relatives and friends mourn his departure. He was converted in early manhood and united with the Defenseless Mennonite church of this place, of which he remained a member until his death.

Bro. Neuhauser submitted to an operation Nov. 8th, from which time he was critically ill. He bore his affliction patiently, and during his sickness was fully resigned to the will of his Heavenly Father.

He was well known among his large circle of friends, as a prominent farmer and interested in numerous business enterprises.

LOCAL WOMAN BADLY INJURED IN COLLISION

Mrs. Elmer Yoder Crashes Into School Bus; Is In Hospital

Mrs. Elmer (Florence) Yoder of this place was seriously injured at 3:30 o'clock Wednesday afternoon when the car she was driving crashed into the rear of a Wabash township school bus, driven by Edwin Bixler. The accident happened on U.S. highway 27, just in front of the Augsburg Filling Station one mile north of Geneva.

Mrs. Yoder is a patient at the Adams County Memorial hospital where her condition is said to be serious but satisfactory, and it is believed that she will recover nicely unless complications set in. She suffered two bad gashes on her forehead, each one being nearly four inches long. She also suffered a badly cut lower lip. 25 stitches were required to close her head wounds. Mrs. Yoder also suffered several fractured ribs on

her right side, badly injured knees and severe bruises. X-ray pictures are to be taken today to determine the extent of her injuries.

Mrs. Yoder was following the bus, when the bus stopped she was unable to bring her car to a stop in time and crashed into the rear end of the bus. None of the children on the school hack were injured. Mrs. Yoder was brought to the office of a local doctor and was then taken to the hospital. The car she was driving was brought to Christy's Garage here. The front end was badly damaged.
