BERNE NEWS

Mike Zehr, Sam Zehr, Edward Yancy and daughter Edna Yancy, Mary Zehr, and ??? Lehman, all of the Lowville, New York community, visited in this community the first part of the week. They stopped here on their return trip home after visiting in Kansas ("Iowa" written in parenthesis) and other states.

One of the busiest industries in this community these days is the Liechty cannery just north of the Berne tile mill. Rufus Liechty started the cannery three years ago and now employs quite a few people. Sweet corn, pickles, tomatoes and other truck crops are being canned now.

Mrs. John P. Mazelin of Berne has received word of the death of her father, Christian Kirchenbuhler, 7?, who lived in Unter den Linden, in Wurtemberg, Germany. Death occurred on June 12 but no details have been received.

Word has been received here of the marriage of Florence Soldner Patterson, of Pendleton, daughter of Mr. and Mrs. John C. Soldner, of near here, to Ruldolph Brauner, of Anderson. The couple will live at Anderson where Mr. Brauner is employed.

BERNE NEWS

One of the largest funerals held in this community recently was that of Evert O. Rich, 43 year old French township farmer, who was killed Monday when a team of horses hitched to a grain binder bolted, dragging Rich to his death. The funeral was held at the Defenseless Mennonite church, the main auditorium, the balcony, and the basement being filled. Burial was made in the M.R.E. cemetery instead of the Defenseless church cemetery as first announced. The true and exact version of how Rich met death will never be known, but it is believed that he was repairing something in front of the binder when the horses bolted. Unable to get out of the way, Rich became tangled up with part of his body underneath the platform and part doubled over the cutting bar on top of the platform. While death probably occurred within a few minutes, he no doubt suffered immensely for some time. Besides being badly cut and mutilated, his entire body was crushed and there were many fractures. His body was found by the youngest son, Maynard, age 11, who went to investigate when he failed to answer the call for dinner.

Rev. Edward Roswog of South Bend, a cousin of the groom, received the double ring vows before an altar decorated with pink roses and white lillies. Baskets of flowers carried out the color motif of pink and white.

The nuptial high mass was sung by the girls choir, with Darwin Leitz as the organist. Miss Frances Ulman, cousin of the groom, and John F. Schurger, brother of the bride, were the attendants. The Nuptial March was played for the processional.

The bride wore a lovely gown of white satin crepe, fashioned princess style with buttons down the back and a sweetheart necklace with pearl trimmings and long sleeves ending in points at the wrists. The full skirt carried a long train. A long veil with train effect fell from the pearl cap which also had an over veil, shoulder length. She carried a shower bouquet of white roses, snapdragons... (crease)

....was held at the Schurger home west of the city. The serving table was centered with a five-tiered wedding cake and the entertaining rooms were beautifully decorated with flowers carrying on the earlier motif of pink and white.

Out of town guests included Mr. and Mrs. Clem Gase and family of Findlay, Ohio; Edward L. Gase of Van Wert, O.; Mr. and Mrs. Frank Kurber and family and Mrs. Margaret Kurber of Delphos, O.; Mrs. Eva Starost of Fort Wayne; Mrs. George Allig and Miss Madeline Allig of Indianapolis; Mr. and Mrs. C. E. Morris and daughter, Mary Jane, of Midland, Mich.

After the reception, Mr. and Mrs. Gase left on a wedding trip of unannounced destination, after which they will be at home in Decatur.

The bride has been a stenographer in the offices of the Schurger ??? and affiliated with the Adams County National ??? and the Muncie Production credit association.

The groom is associated in business with the Mutschler Packing company.

MAN HURT IN FALL...STILL UNCONSCIOUS

William Meyer, 35, son of Fr? Meyer of northwest of town, critically injured Wednesday morning when he fell from the hay mow, through a chute ?? the concrete floor of the barn at the Ed Stahly farm in Wabash township, is still in a critical condition and had not regained consciousness this afternoon.

Meyer had just started to work for Mr. Stahly the day preceding the accident.

It is believed that he slipped as he was about to descend down a ladder in the chute, and fell on the concrete. He suffered a fractured skull and numerous other injuries. Meyer was found on the barn floor by Chris Stahly after he failed to respond to a call. He was unconscious when he was found.

Mr. Meyer was admitted to the Adams County Memorial hospital after he had first been taken to the home of his father-in-law, Lendel Neal, at Geneva.
