#### TWO DIVORCE SUITS FILED

Berne Murder Witness One Complainant; Other Decatur Case

Two suits for divorce were filed in Adams circuit court before Judge J. Fred Fruchte Tuesday.

Martha Schindler, of Berne, has brought action for divorce against Samuel Schindler, also of that town, charging cruel and inhuman treatment. The complaint also alleges failure to support. She asks also for the restoration of her maiden name, Martha Brown.

Mrs. Schindler's name was first brought into the news limelight last December when she identified Jerry Mangano, Chicago thug, as the killer of Anthony Michaud during a robbery at Berne in August, 1939.

The other suit is brought by Don Aeschliman, local grocery clerk, against June Aeschliman. The complaint, charging cruel and inhuman treatment states that they were married September 30, 1935 and separated August 26, 1940.

An affidavit for a restraining order was also filed by the plaintiff. D. Burdette Custer is plaintiff's attorney in both suits.

### PARALYSIS SEEMS TO BE ON THE INCREASE

Cases of infantile paralysis in Indiana climbed to 214 today as two additional deaths were reported to raise the toll of fatalities to more than 20.

Yesterday's fatalities included ?orace Ransdell, 28, of Muncie and Marie Hammond, 2, of Mishawaka.

Ransdell, a Y.M.C.A. worker, died at Ball State hospital at Muncie after being ill four days. The Hammond baby died after treatment in an artificial respirator. Her death was the seventh caused by the disease in St. Joseph county this summer.

Three cases were reported in Huntington county, one of which proved fatal to Betty Wintrode, ?0. The others are Judy Taylor, age 2, and Roger Rinebolt, 6, son of Mr. and Mrs. Guy Rinebolt, formerly of Berne.

John Wittwer, age 3, son of Mr. and Mrs. John Wittwer, North Manchester, formerly of Berne, is reported "improving" at the Riley hospital in Indianapolis.
