ROBERT STENGEL, 15, DIES OF INJURIES RECEIVED IN FALL Funeral for Victim of Polio Myelitis Saturday P.M.

The whole community mourns the passing of R

The whole community mourns the passing of Robert James Stengel, 15, intimately known as "Bobby," who died last evening at 5:10 o'clock, at the home of his parents, Mr. and Mrs. Ernest Stengel on West Main street. He was their only child.

Death was caused by spinal inflammation which apparently was the result of injuries received in a fall on August 23. The youth fell a distance of about 12 feet from the barn loft at his parents home where he had a den. Details of the circumstances surrounding

the whole trunk and the upper extremities, finally completely paralyzing the whole body. His attending physician called the county health officer into consultation as to whether he would place a quarantine. He carefully examined the patient and was in hopes, as was the attending physician, that "Bobby" would recover. However as the disease progressed it resulted in Anterio Polio Myelitis, and according to the (cut off) ...ored by the Berne Chamber of Commerce and a member of the Mennonite church. Mrs. Alvine (crossed out and handwritten: "Aldine") Augsburger, 52, well-known Jefferson township lady and wife of Albert Augsburger died this morning at 1:30 o'clock at her home southeast of Berne. Death followed an illness of three years and was attributed to carcinoma.

The deceased was born in Berne, February 22, 1888, the daughter of Chris and Josephine Baumgartner Wittwer. She was married to Albert Augsburger on September 30, 1933.

Surviving besides the husband are four step-children, Mrs. Gladys Yoder, Gordon and Delbert, of Berne, and Warren, at home; following brothers and sisters, Noah Wittwer of Fort Wayne, Ed and (cut off)...Otto of Fort Wayne, Amos, Lee and Adolph of Wells county, Jesse of Berne, Albert of Linn Grove and Miss Edna Wittwer of Berne.
