#### FOURTH POLIO VICTIM'S RITES ON WEDNESDAY

#### Carl Pequignot, Businessman, Dies Less Than Week After Becoming Ill

Funeral services, for relatives only, will be held Wednesday for Fort Wayne's fourth poliomyelitis victim, Carl P. Pequignot, 32, 622 Stadium Drive, who died at 3:20 p.m. Sunday at St. Joseph's Hospital, following an illness of less than a week. His legs, arm and abdominal muscles were paralyzed.

Rites will be held at the Ankenbruck Funeral Home at 8:30 a.m. Wednesday and again at St. Jude's Catholic Church, of which Mr. Pequignot was a member, at 9 a.m., the Rev. John A. Dapp officiating. Burial will be in Catholic Cemetery. On Tuesday at 8 p.m. the Holy Name Society of the church and the Knights of Columbus will meet at the funeral home for recitation of the rosary.

Mr. Pequignot was vice-president of the Main Auto Supply Company. He had traveled considerably in recent weeks as manager of the sporting goods department and a week before he became ill had attended a coaches' convention at Logansport. It cannot be determined (cut off)

Fifteen years ago, Mr. Pequignot was a star left halfback on the Central Catholic High School football team. He later attended John Carroll University, where he was an athletic star.

He became affiliated with the Main Auto Supply Company 10 years ago. He was president of the Fort Wayne Figure Skating Club, which he helped organize last fall.
