FORMER RESIDENT OF GENEVA KILLED AS PLANE CRASHES Mrs. C. Arthur Ross and Husband are Killed as Plane Crashes Monday Night in East (cut off)

Bluffton, Ind., Oct 1 - (Special) Former Geneva and Bluffton girl, Mrs. C. Arthur Ross, who will be ?? remembered here as Miss ??her McKissic, and her husband, a captain in the engineering corps of the U.S. air branch, were both killed instantly late Monday evening when a Bellanco airplane, bought a month ago by Capt. Ross, crashed at Walterboro, South Carolina.

Mrs. Ross was about 40 years old and her husband 37. The mother of Mrs. Ross is

Mrs. Anna McKissic, who resides on Lancaster street in Bluffton, and the ??her, Don, is a linotype operator on the Bluffton News-Banner. She has two sisters, Mrs. Lawrence (Genevieve) Nute of Chicago and Mrs. Lester (Gwendolyn) Wagner ??. Her father, V. E. McKissic, died nearly two years ago. At one time Mrs. Ross lived at Geneva in Adams county.

The crash at Walterboro occurred in a pine thicket (cut off)

....pilot in a landing attempt, however, the plane crashed with terrific force and was completely demolished, parts of the machine ..??ing considerable distance.

The log found in the cabin revealed that the couple had been on a vacation trip and that early ??nday they had refueled at Mon??, Louisiana. So far as it could be learned, no other landing had been made before the crash at Walterboro. Papers found on Ross

identified him as an aviation captain and two magazines bore the ??ss of Mrs. Ross. Walterboro residents stated that the plane had flown over their ?? from the south and that it sounded as if the engine was giv?? trouble.

Captain and Mrs. Ross, relatives at Bluffton stated, had attended a Bluffton street fair a year ago and had planned to be there for the ?? this fall, but had decided to take a vacation southward in their plane. Both liked to fly and had jokingly remarked that if an accident befell either of them the other would be killed too as they were almost

always together. Mrs. Ross was a graduate nurse and for a short time employed at the Wells county hospital. She was in government service during the World War and later employed at the Hines Veteran's hospital. ...later she was transferred to the Panama Canal Zone, where ? years ago she became acquainted with Capt. Ross. Three years ago she was transferred to the ??ion field at Dayton, Ohio, whereupon the Bluffton girl

resigned her nursing position at the Canal Zone and was married to ??in Ross immediately upon (cut off)

Her attendant wore soldier blue with hat to match. Black accessories and a corsage of

pompoms completed her costume.

A reception was held at the home of the bride's parents for members of the immediate families and Rev. and Mrs. Hart and daughters, Virginia and Ruth.

After the reception the couple left on a wedding trip of unannounced destination. The groom is a graduate of the Monroe high school and the bride also attended Monroe high school. For the present, Mr. and Mrs. Hook will make their home with the

former's parents.
