Milton E. Hower, 67, prominent Decatur resident and former businessman, died suddenly Wednesday morning at his home on First Street. Death was attributed to

coronary thrombosis.

He was found dead in bed about 1:30 o'clock. Death came as a distinct shock to the

members of the family and friends, many of whom did not know he had been ailing.

Mr. Hower was one of Decatur's most active civil and school leaders, having served for six years as a member of the city board of education, taught in the rural and city schools and serving as principal at the West Ward School a number of years.

For 35 years, he operated the Hower Grocery at Monroe and Seventh Streets. At the time of his death, he was employed as an investigator in the auto license bureau of the

state. He was also an active Democratic worker and at one time was a candidate for the Democratic nomination to the office of county recorder and was deputy sheriff for two terms.

Mr. Hower was well known in Berne. He was at the Berne Review Office every

Saturday forenoon to give driver's test to beginners. No announcement had been made today as to who will succeed Mr. Hower or if anyone will be here to give tests next Saturday.

He was a devout member of the First Methodist Church and fraternally was a charter member of the Loyal Order of Moose and the B.P.O. Elks; also a member of the Knights of Pythias and the Decatur Masonic Lodge.

Lifelong Resident

He was a lifelong resident of the county. He was born at Decatur December 31, 1871, the son of Adam and Barbara Steele-Hower. On November 9, 1904, he was married to

Maud Scott, who survives.
