Otto C. Smith Jr., 23, Is Killed When Ship Takes Nose Dive Near Berne

Daniel Moulton, Indiana inspector for the Civil Aeronautics Authority, today began an investigation of the fatal airplane crash of a farm northwest of Berne in which Otto C.

Moulton, it was said, will make an inspection of the plane and interview those persons who saw the plane in flight.

DIES ON BIRTHDAY

Smith, who died at 3:25 o'clock Sunday afternoon in the Adams County Memorial Hospital at Decatur of broken legs, a basal skull fracture and shock, was the third

member of his family to meet death in a plane. The youth's father, Otto C. Smith, was killed when his plane went into a tailspin and crashed during an exhibition at Montpelier in 1927, and the latter's cousin, Art Smith, Fort Wayne's bird boy was killed near Bryan, O., while flying the U.S. mail. (cut off)...onca C-3 which he purchased recently. He was attempting to make a landing on the Mennas Wulliman farm, five miles northwest of Berne. He had circled the field and was preparing to land when the plane suddenly dived, striking the ground nose first.

While the exact cause of the accident is not known yet, it is believed that he pulled the plane up suddenly to avoid some wires and that it stalled. He had too little altitude to pull out of the stall, and the craft plunged to the earth. The fatal crash occurred on the youth's twenty-third birthday. He was born near Monroe on March 30, 1918, and spent his early years in Adams County. He started to

fly in March, 1938, and soloed on January 3, 1939. He received his flight instruction from O. B. McVey, of the Inter-City Flying Service. Smith was employed by the Rea Magnet Wire Company. Surviving are the widow,

Mrs. Alice Smith; a son, Carl David; and the grandparents, Mr. and Mrs. Simon Smith. The body was taken to the Yager Funeral Home in Berne and will be removed late today to the home of his father-in-law, Joseph Baumgardner, east of Berne.

Funeral services will be held Wednesday afternoon at 1 o'clock at the residence and at

2 o'clock at the Cross Reformed Church at Berne. Burial will be in the MRE cemetery.
