...IN SHOOTING FRAY IN COUNTY FRIDAY

Jesus Velez, 78, in Critical Condition - Man Held on Open Charge

Jesus Velez, 78, Mexican beet worker, who was gravely wounded last Friday when a bullet was fired through his body, is reported to have lost ground this afternoon in his return to recovery, according to attaches at the Adams County Memorial hospital. His condition was reported as being "just fair" and that it is not as good as it had been a day or two ago.

Jesus Chavez, 41, alias Prado Chavez, a Mexican beet worker, is being held on an open charge in the Adams county jail at Decatur pending the outcome of a bullet wound he is alleged to have inflicted on Jesus Valez, 78, with a revolver during an argument at Valez' home in Curryville southeast of Decatur at 8:30 Friday morning.

Valez, according to latest reports is still in a critical condition at the Adams county memorial hospital, although his condition has shown slight improvement. The bullet passed entirely through his body, entering at the groin and passing out at the back of the hip.

The bullet was shot from a .41 caliber old model revolver allegedly fired by Chavez, who also goes by the name of Prado, according to the Spanish custom of using both parents' names.

Officers who investigated the shooting were Ed Miller and Deputy Leo Gillig, of Adams county; State Patrolman Truman Bierie and Deputy Sheriff Robert Miller, of Bluffton.

They were informed that Chavez, who is a tenant on Velez' small farm, got into an argument with Valez over rents. Valez is also reported to have accused Chavez of killing a goat owned by Valez. During the heat of the argument Chavez is alleged to have drawn the old revolver and to have fired the weapon which struck Valez in the abdomen and passed on through his body.

Immediately after the accident Chavez and his wife drove away in an automobile and were the objects of an extensive search which ended about an hour later when Chavez appeared at the Adams county court house in Decatur and surrendered.

The wounded man was rushed to the Adams county hospital.

Valez is well known to police in both counties by reason of law violations in the past. He served a penal farm term in recent years for possession of marijuana, or "loco weed."

Since Chavez is unable to speak English, they will need an interpreter to get his version of the argument that led up to the shooting. On the basis of preliminary investigation, authorities said Valez's death probably would mean filing a first degree murder charge against. Chavez.
